

General conditions



1. Participation

Participation in the European Koi Show is possible for anyone who fits into the concept of the show. All the necessary show information can also be found on our website https://www.europeankoishow.com/

Payment must be made to the account number of Koiclub Nederland before the payment date stated on the invoice.

The allocation of the stand is done exclusively by the members of the board of Koiclub Nederland. Koiclub Nederland determines your location and it is not transferable. Of course, it is not permitted to use the assigned pitch by others, whether or not for a fee, under penalty of an increase of the rent by 100% with due observance of article 3 stipulated.

2. Refusal

The board of Koiclub Nederland, as well as all persons authorized by it, have the right to refuse anyone access to the show site, the intermediate road from the parking lot to the show site as well as participation in the show without giving any reason.

3. Payments

After receipt of the invoice, the payment of the registration fees must be made within eight days. After receipt of the registration fees, the final pitch will be assigned by the board of Koiclub Nederland. Late payment may mean that you will not be placed in your desired place.

4. Termination

Cancellation can only be done in writing and by registered mail to the person in charge of Koiclub Nederland, and with clear reasons at least 8 weeks before the show.

After this, 50% of the rent already paid will be refunded. However, if cancellation takes place after this period, no refund can be made. Unpaid rent will remain due to Koiclub Nederland, with due observance of the provisions of article 3.

5. Assembly and dismantling

The exhibitor has the opportunity to set up and furnish the stand on Friday 23 May 2025 from 09:00 to 19:00. At 19.00h sharp, you must have left the show grounds. In consultation with the Koi Club Netherlands, it is also possible to build up on Thursday 22 May 2025.

Cleaning up and dismantling the stand is allowed on 25 May 2025 after 17:00 and/or on 26 May 2025 from 08:00 to 13:00. Material that is still on site at a later date will no longer be supervised by Koiclub Nederland.

During the show itself, it is forbidden to dismantle or evacuate a stand! The booth must be open to the public on all days of the show. Not having the stand open or not being present does not entitle you to a refund of the registration fee.

The stand must be set up on the rented surface. It is forbidden to exhibit or place articles outside this area without the permission of Koiclub Nederland, or by its authorized persons.

You can only hang your materials IN your own stand **WITHOUT** damaging the stands, so with fasteners to the pipes and **NOT** to the fabric itself.

Only banners, flags and signs for which sponsorship money has been paid will be hung by the organization on the show grounds. All materials that are hung by you outside your own stand and that have not been paid for, will be removed immediately!!

It is expressly forbidden to let water flow over the site before, during and/or after the show. If this is the case, the damage caused to the site, or damage caused to the property of third parties, will be recovered from the exhibitor.

To prevent damage to the site, trailers and trucks are not allowed on the site.

We therefore kindly ask you to unload as soon as possible at the **rear** of the stand and then remove the vehicles from the site.

The stand must be left completely empty (i.e. without waste) and intact.

6. Koi Sales/Filters

All sales bins containing live fish must be equipped with a proper filtration system with sufficient capacity.

The stall holder must ensure that the fish kept in the stands cannot jump out of the tanks/barrels.

In the absence of the exhibitor, these fish will immediately become the property of Koiclub Nederland.

Koiclub Nederland supervises the quality of housing and the health of the fish offered for sale.

If Koiclub Nederland is of the opinion that the sale is irresponsible, it will force the exhibitor to stop the sale of the fish offered and to take appropriate measures.

7. Force majeure and cancellation of the show

If, beyond the control of the board of Koiclub Nederland, such as the death of one or more main persons, a day of national mourning, natural disasters or other events that may give rise to this, the Euroepean Koi Show has to be cancelled in its entirety, Koi Club Nederland will refund the registration fees already paid, after deduction of the costs incurred by Koi Club Nederland for the benefit of the participant. However, Koiclub Nederland is not liable for the costs incurred by the exhibitor for the benefit of the show, or lost income.

8. Catering

It is not allowed to offer or exploit drinks and/or food on the grounds of the show, unless otherwise agreed with Koiclub Nederland and confirmed in writing.

9. Vehicles and parking

It is only allowed to drive a (motor) vehicle on the route indicated for this purpose and/or instructions by Koiclub Nederland.

All vans, trailers, motorcycles and other vehicles must leave the show grounds by 09:00 at the latest on 24.05.2025 and be parked in the designated parking lot.

On Sunday, May 25, 2025, it is only allowed to drive on the site with motor vehicles after 17:00 and this according to the instructions of the authorized persons.

Further instructions on this will be given during the show.

10. Video Audio

It is allowed to use audio and video material, provided that no nuisance is caused to your close exhibitors or organisation.

Also pay attention to the legal guidelines imposed by Buma Stemra. This must be arranged by the exhibitor himself with the competent authorities. Koi club Nederland takes no responsibility for this.

11. Electra

The stand is equipped with a proper electricity supply.

The exhibitor is obliged to only connect sound and approved (according to CE approval or NEN 1010) equipment to this installation. (extension cable max. 25 meters is to be provided yourself). Koi Club Nederland is not liable for any damage caused by equipment connected to this installation.

Per stand, max. 500 watts can be connected to the system.

Due to the high wattage, it is not allowed to connect coffee machines yourself.

For exhibitors, coffee will be available for a fee at the association stand of Koi Club Nederland.

12. Monitoring

The show grounds will be guarded from Tuesday 21 May 2025 from 20:00 until Monday 26 May 2025 during closing hours.

The security authorized by Koiclub Nederland will be on the site during the entire show and may not be denied access to the stands.

The security guard is authorized to do and/or refrain from doing everything it deems necessary to ensure the safety of visitors and participants.

The instructions given by the security service must be followed immediately

13. Risk and rights

- a. The board of Koiclub Nederland and/or its employees is/are in no way liable for damage and/or loss of any kind that occurred before, during or after the show.
- b. The exhibitor as well as their employees are liable for all damage whatsoever caused in or by their stand as well as for all damage caused with or by their goods, vehicles, by their actions, or by their negligence on or in the immediate vicinity of the show grounds.
 - Koiclub Nederland does not accept any liability and is entitled to recover damage resulting from claims by third parties directly from the exhibitor and/or his employees.
 - Employees are also

is/are in no way liable for damage, illnesses and/or deaths to Koi that are present at the show or during transport to and from the show.

- d. Participants are not allowed to advertise and/or make announcements outside the rented space or stand.
- e. The participants are required to be open to the public on all show days.

14. Derogations

Deviations from these General Terms and Conditions of the European Koi Show 2025 are only possible after written permission from the board of Koiclub Nederland.
